Commander (Sel.) Jamar Q. Green **Region Legal Service Office Europe Africa Central** **Reserve Pay Officer | Asst. Training Officer**

Commander Jamar Q. Green currently serves as the RESPAY Officer and Assistant Training Officer at Region Legal Service Office Europe, Africa, Central (RLSO EURAFCENT), where he oversees reserve manpower readiness and professional development across a tri-combatant command area of responsibility. He manages training coordination, mobilization planning, and legal force generation in support of Navy missions spanning Europe, Africa, and CENTCOM.

A native of Pineville, Louisiana, Green was commissioned in 2006, after graduating from the United States Naval Academy in Annapolis, Maryland.

He began his naval service as a Surface Warfare Officer (“SWO”) before transitioning to the JAG Corps.

Commander Green served on active duty as a SWO from 2006 to 2013. His shipboard assignments included tours aboard USS BOXER (LHD 4) and USS CURTS (FFG 38) in San Diego, California; the United States Military Training Mission (USMTM) to the Kingdom of Saudi Arabia; and Navy Recruiting District Chicago. While aboard *BOXER*, he served as Electrical Division Officer, leading a team of over 30 sailors in electrical, auxiliary systems, and damage control readiness. He qualified as Engineering Officer of the Watch and earned his Surface Warfare Officer designation, contributing to successful INSURV, ULTRA-S, and deployment certifications. On *CURTS*, Commander Green served as Auxiliaries Officer, overseeing the maintenance and operational readiness of all auxiliary systems that support shipboard life and mission execution to include air conditioning and refrigeration units, hydraulic systems, ventilation, potable water production and distribution, sewage and waste handling, and firefighting support equipment. As an instructor to Royal Saudi Naval Forces officer candidates at the Officers School in Al Jubail, Saudi Arabia, Commander Green delivered professional military education and tactical instruction to strengthen bilateral defense cooperation and operational interoperability. As Division Officer for Division 5 at Navy Recruiting District Chicago, he led enlisted recruiters across Northern Illinois while personally managing an officer accession quota. His efforts earned him recognition as the Officer Recruiter of the Quarter for the fourth quarter of Fiscal Year 2012. Throughout his SWO tenure, Commander Green was recognized for technical acumen, deck-plate leadership, and mission-first execution, earning a number of awards.



In 2018, Commander Green redesignated to the JAG Corps following his tenure at Tulane University Law School (2013-2016) and two years into his civilian role as Assistant District Attorney at the New York County District Attorney’s Office in New York, New York. From his first JAG assignment under CAPT John S. Han with RLSO Navy District Washington, Commander Green volunteered for Direct Recall Orders to serve three years as an active duty Victims’ Legal Counsel under CAPT Lisa Sullivan and thereafter CAPT Daniel Cimmino. As Victims’ Legal Counsel, Commander Green provided independent legal representation to over 150 victims of sexual assault and other crimes across multiple Navy Region Southwest, ensuring their rights were protected throughout the investigative and judicial process. He coordinated with trial counsel, NCIS, and command leadership to deliver trauma-informed advocacy, safeguard privileged communications, and represent clients in 11 courts-martial and numerous administrative proceedings.

In his civilian capacity, Commander Green is an Associate at Gordon Rees Scully Mansukhani LLP in New York City, where he leads complex commercial litigation across state and federal courts. He manages high-stakes case posture development, discovery strategy, and causation analysis, delivering AM100-level results while mentoring junior attorneys and contributing to firm-wide professional development initiatives.

His personal awards include the Navy and Marine Corps Commendation Medal, Navy and Marine Corps Achievement Medal (three awards), and multiple Letters of Commendation. He has been cited for superior performance in trial advocacy, strategic litigation planning, and command-level legal support.
